Rocky Horror (checked and lost ground from turning out of the back straight and subsequently tailed off) underwent a post-race veterinary examination and was found to have a left back muscle injury. A 14 day stand down period was imposed.

5:37 pm 425m Grade 5 A race day urine sample was taken from Squiggly Papa at the trainer's kennel earlier today.

A pre-race urine sample was taken from Lala Noel.

Senna Forever was quick to begin.

#### Race 13

BENDIGO RACE 13 (300+RANK)

5:54 pm 425m Grade 5 Hydro Glide was quick to begin. Mini Minion was slow to begin.

Hydro Glide (marred Mini Minion in the home straight) underwent a post-race veterinary examination - no injury reported. Stewards spoke to trainer Mr Kevin Ashton regarding the greyhound's racing manners. Acting under the provisions of GAR 123, Hydro Glide was charged with marring. Mr Ashton pleaded guilty to the charge. Hydro Glide was suspended for three months at all tracks and must perform two satisfactory trials in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Satisfactory Trial Results:

River George – FTP – Field of 4, Distance: 425m, Weight: 31.7kg, Box 1, Placed 1st, Time Run 24.637 – Comment: Cleared all tracks.

Little Tic – Blinkers OFF – Field of 4, Distance: 425m, Weight: 26.8kg, Box 7, Placed 3rd, Time Run 25.002 – Comment: Cleared to race without blinkers.
