A margin was visible in the photo finish image with the actual finishing time for Talk That Talk being 29.7656 compared to 29.7661 for Scotch Time. However, as FastTrack is limited to displaying three decimal places, both times were automatically rounded to 29.766, and as such no margin is displayed in FastTrack.</p>

<p>Race 2 TOONGABBIE LODGE (300+ RANK) 6:26 pm 515m Grade 5 No Penalty</p>	<p>Bobby Baccala was slow to begin.</p> <p>Bun Quake (checked and lost ground turning into the back straight), underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Following the event, Bobby Baccala displayed mild signs of Post Exercise Distress Syndrome (PEDS). As a result, the greyhound underwent a post-race veterinary examination and was found to be displaying clinical signs of ataxia/hypermetria. A 5 day stand down penalty was imposed. Stewards spoke to Luke Smith, the trainer of Bobby Baccala, and advised him that the greyhound would be closely monitored in future starts.</p>

A 7 day stand down period was imposed.</p> <p>Panda Bella (severely checked on the first turn) underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Red Rocks Beauty (severely checked on the first turn) underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Stewards spoke to trainer Mr. Mario Briganti regarding the racing manners of Red Rocks Beauty turning off the back straight. After hearing submissions from Mr. Briganti, viewing the available race footage and having their own observations, Stewards took no further action.</p>
