Acting under the provisions of GAR 123, Aston Botan was charged with marring. Mr. Treherne pleaded guilty to the charge. Aston Botan was suspended(2nd offence) for 28 days at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
