<p align="center"><b>Race 1</b></p> <p align="center">13 RACES TONIGHT</p> <p align="center">1:59 pm 390m Maiden</p>	<p>Johnny Runaway and West On Beattie were quick to begin. Eat Less Junk, Whistling By and Sassy Stokes were slow to begin.</p> <p>Johnny Runaway (marred West On Beattie in the home straight) underwent a post-race veterinary examination - no apparent injury reported. Stewards spoke to Mr. Matthew Clark regarding Johnny Runaway's racing manners. Acting under the provisions of GAR 123, Johnny Runaway was charged with marring. Mr. Clark pleaded guilty to the charge. Johnny Runaway was suspended for 28 days (1st offence) at Shepparton and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>West On Beattie underwent a post-race veterinary examination - no apparent injury reported. Stewards spoke to Ms. Adele Powell regarding the racing manners of West On Beattie subsequent to being marred by Johnny Runaway. Stewards also noted that West On Beattie's muzzle became partially lodged in the greyhound's mouth during the running of the event. After hearing submissions from Ms. Powell, viewing the available race footage and having their own observations, Stewards took no further action. In arriving at this decision, Stewards took into consideration the significance of the interference caused to West On Beattie by Johnny Runaway and the likely effect this interference had on the racing manners of West On Beattie.</p> <p>Whistling By (ran wide and severely collided with Magic Scotch turning off the back straight) underwent a post-race veterinary examination and was reported to have sustained a spike wound on the right fore. A 3 day stand down period was imposed. Stewards spoke to Kennel Representative Mr. Joshua Duncan regarding Whistling By's performance and racing manners turning off the back straight. After hearing submissions from Mr. Duncan, viewing the available race footage, and acting on their observations, Stewards issued a warning. Stewards will monitor Whistling By's racing manners in future events.</p> <p>Sassy Stokes (raced wide entering the home straight and turned its head outwards in the home straight) underwent a post-race veterinary examination - no apparent injury reported. Mr. David Shovan declined the opportunity to have the greyhound re-examined. Stewards spoke to Mr. Shovan regarding Sassy Stokes' racing manners. Acting under the provisions of GAR 124, Sassy Stokes was charged with failing to pursue the lure with due commitment. Mr. Shovan pleaded guilty to the charge. Sassy Stokes was found guilty and suspended for 28 days (1st offence) at Shepparton and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
