<p><b>Race 1</b> SPORTSBET MAKE IT A MULTI 6:09 pm 400m Tier 3 - Maiden</p>	<p>A pre-race urine sample was taken from Albatross Wings.</p> <p>Albatross Wings, Sleek Design and Stalking Douglas were slow to begin.</p> <p>Gizmo Flyer (faltered turning off the back straight) underwent a post-race veterinary examination and was found to have injuries to the right triangle and left wrist. A 28 day stand down period was imposed.</p>

<p><b>Race 2</b> G'DAY CHEF CATERERS 6:27 pm 400m Tier 3 - Maiden</p>	<p>Aston Richie – New declared weight of 33.2kg, last raced at 34.8kg.</p> <p>Best Dressed was quick to begin.</p> <p>Aston Richie underwent a post-race veterinary examination – no apparent injury was reported. Stewards spoke to Ms. Lyn Smith regarding the racing manners of Aston Richie in the home straight. After hearing submissions from Ms. Smith, viewing the available race footage and having their own observations, a warning was issued.</p> <p>Due to a malfunction with the timing equipment, an incorrect time of 19.656 was initially displayed.</p> <p>Supplementary Advice 13/12/24 - The event was subsequently hand-timed. The times recorded for all greyhounds are hand timed. No sectional times were recorded.</p>

Boil The Billy was slow to begin.</p> <p>A post-race urine sample was taken from Cordova – the winner of the event.</p> <p>Due to a malfunction with the timing equipment, an incorrect time of -7.925 was initially displayed.</p> <p>Supplementary Advice 13/12/24 - The event was subsequently hand-timed. The times recorded for all greyhounds are hand timed. No sectional times were recorded.</p>

<p><b>Race 4</b> RSN GREY AREAS - WEDNESDAY &amp; FRIDAY 7:07 pm 400m Grade 5 T3</p>	<p>Freeman Bale (faltered soon after the start and subsequently tailed off) underwent a post-race veterinary examination and was found to have a right hock injury. A 28 day stand down period was imposed.</p> <p>Compton Gumdrops (checked turning off the back straight and lost ground thereafter) underwent a post-race veterinary examination and was found to have a right back muscle injury. A 60 day stand down period was imposed.</p> <p>Raised Right underwent a post-race veterinary examination at the trainer's request and was found to have injuries to the left hock and triangle. A 28 day stand down period was imposed.</p> <p>Due to a malfunction with the timing equipment, an incorrect time of -11.190 was initially displayed.</p> <p>Supplementary Advice 13/12/24 - The event was subsequently hand-timed. The times recorded for all greyhounds are hand timed. No sectional times were recorded.</p>

<p><b>Race 5</b> DREAMCHASERS - TICKETS ON SALE NOW 7:27 pm 400m Grade 5 T3</p>	<p>A pre-race urine sample was taken from La Lina.</p> <p>The start was delayed by approximately two minutes due to operational activities.</p> <p>La Lina was quick to begin.</p> <p>La Lina (turned its head in the home straight) underwent a post-race veterinary examination and was found to have a right hind spike wound. A 3 day stand down period was imposed. Stewards spoke to Mr.</p>

Stavros Kipirtidis regarding La Lina's racing manners in the home straight. Acting under the provisions of GAR 124, La Lina was charged with failing to pursue the lure with due commitment. Mr. Kipirtidis pleaded not guilty to the charge. La Lina was found guilty and suspended for three months (3rd offence) at all tracks and must perform two Satisfactory Trials in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Locked And Ready underwent a post-race veterinary examination and was found to have right fore torn nail. A 7 day stand down period was imposed.

Black Pistol (faltered and lost ground turning off the back straight) underwent a post-race veterinary examination and was found to have a right back muscle injury. A 60 day stand down period was imposed.

A post-race blood sample was taken from La Lina - placed 2nd in the event.
