Trainer, Ms. Maria Barber, declined the option to have the greyhound re-examined. Stewards spoke to Ms. Barber regarding Ms Daisy Mikado's performance throughout the event. After hearing submissions from Ms. Barber, viewing the available race footage and acting on their observations, Stewards deemed the performance of Ms Daisy Mikado unsatisfactory. Ms Daisy Mikado must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.

Supplementary Report 29 January 2025: Trainer Ms Jodie Leek, notified Stewards in accordance with GAR 122 that Lovely Memories was found to have a tibia injury and has received veterinary treatment.

Supplementary Advice 26/2/2025 - Following post-mortem examination of Apache Shout, acute cardio-respiratory failure with pulmonary haemorrhage was confirmed as the cause of death.

Too Cold and So You Assume were slow to begin.

Luna Mikado and Too Cold collided entering the back straight, resulting in Luna Mikado falling and Too Cold stumbling and losing ground. These greyhounds underwent post-race veterinary examinations:

- Luna Mikado was found to have injuries to the left triceps muscle and right thigh, as well as a laceration to the right wrist. A 10 day stand down period was imposed.
- Too Cold was found to have a small laceration to the left-foreleg. No stand down period was imposed.

Honey Bunny (marred So You Assume in the home straight) underwent a post-race veterinary examination -no apparent injury was reported. Stewards spoke to trainer Ms. Angela Langton regarding Honey Bunny's racing manners. Acting under the provisions of GAR 123, Honey Bunny was charged with marring. Ms. Langton pleaded guilty to the charge. Honey Bunny was suspended for 28 days (1st offence) at Sandown Park and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
