<p>Race 1 SPORTSBET SAME RACE MULTI (300+ RANK) 11:20 am 350m Maiden</p>	<p>Magic Tigeress turned its head to the inside approaching the 250m mark, underwent a post-race veterinary examination and was found to have injuries to the left monkey muscle and left back muscle. A 14 day stand down period was imposed. Stewards spoke to Mr Lachlan Scott regarding the greyhound's racing manners. Acting under the provisions of GAR 125, Magic Tigeress was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Scott pleaded guilty to the charge. Magic Tigeress must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Big Mizzi was checked at the 250m mark and subsequently tailed off, underwent a post-race veterinary examination - no apparent injury was reported. Mr Lachlan Scott declined the option to have the greyhound re-vetted. Stewards spoke to Mr Scott regarding the greyhound's performance in the event. After hearing submissions from Mr Scott, viewing the available race footage and acting on their observations, Stewards deemed the performance of Big Mizzi unsatisfactory. Big Mizzi must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p>
