Lil Miss Meranda and Rewritten were slow to begin.

Rewritten crossed to the outside soon after the start.

A post-race urine sample was taken from Chilli Pepper - the winner of the event.

Race 6

CENTRAL SCAFFOLDS (300+RANK)

1:05 pm 350m Grade 5 Perfect Sal and Special Sian were quick to begin. Tough Taz was slow to begin.

Tough Taz visibly eased soon after the start and subsequently pulled up, underwent a post-race veterinary examination and was re-examined following event 9. Tough Taz was found to have a left calf muscle injury. A 10 day stand down period was imposed. Stewards spoke to Mr Bryan Sykes regarding Tough Taz's racing manners soon after the start. Acting under the provisions of GAR 125, Tough Taz was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Sykes pleaded guilty to the charge. Tough Taz must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

My Boy Ted marred Get A Grip approaching the winning post, underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to Ms Kylie Norton regarding My Boy Ted's racing manners approaching the winning post. Acting under the provisions of GAR 123, My Boy Ted was charged with marring. Ms. Norton pleaded guilty to the charge. My Boy Ted was suspended for 28 days (2nd offence) at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Our Tie Breaker underwent a post-race veterinary examination at the trainers request and was found to have split webbing to the left hind. A 14 day stand down period was imposed.

1:40 pm 350m Grade 5 Especial Speed – Late scratching at 6:50 pm when trainer Mr. Peter Knott reported the greyhound to have diarrhoea (GAR 76). A 10 day stand down period was imposed.

Ayia The Slayer was quick to begin.

A post-race urine sample was taken from Damaged Panel - the winner of the event.

Nearly Irish - New declared weight of 29.0kg, last raced at 27.3kg.

Nearly Irish was slow to begin.

Nearly Irish (faltered at the 150m mark and lost ground) underwent a post-race veterinary examination and was found to have a right wrist injury. A 10 day stand down period was imposed.

2:32 pm 300m Grade 5 Acting in accordance with the GRV Lightning and Thunderstorm Safety Procedure, racing was suspended at 2:25pm due to continuous lightning strikes within the designated safety zone around the Healesville greyhound racing club. Due to safety concerns, the meeting was delayed by 30 minutes and rescheduled accordingly.

This event was rescheduled to 2:55pm.

Tali Marvel – New declared weight of 34.3kg, last raced at 35.5kg.

A pre-race urine sample was unable to be obtained from Tali Marvel, a post-race urine sample was subsequently taken.

Tali Marvel was slow to begin.

Stewards spoke to Mr Barrie Morse regarding their conduct during a pre-race sample. A warning for inappropriate behaviour was issued pursuant to GAR 165(a).

#### Race 12

300m Grade 5 This event was rescheduled to 3:12pm.

Cosmic Holiday (faltered approaching the 50m mark and lost considerable ground) underwent a post-race veterinary examination and was found to have injuries to the left back muscle and left pencil muscle. A 21 day stand down period was imposed.

Brother Yap (checked soon after the start and lost ground from the 200m mark) underwent a post-race veterinary examination and was found to have a right back muscle injury. A 28 day stand down period was imposed.
