Stewards spoke to Mr Glenn Judd regarding the greyhound's racing manners entering the home straight. After hearing evidence from Mr Judd, viewing all the available race footage and acting on their own observations, Stewards issued a warning to connections. In arriving at this decision, Stewards took into consideration the fall of Moraine Ella in front of Moraine Emma and the effect this incident would reasonably have had on the racing manners of Moraine Emma.</p> <p>There was no head on vision available for this race.</p>

Acting under the provisions of GAR 124, Moraine Alice was charged with failing to pursue the lure with due commitment. Mr Judd pleaded not guilty to the charge. Moraine Alice was found guilty and suspended for 28 days (1st offence) at Warrnambool and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
