No stand down period was imposed. Stewards spoke to Mr Brad Sands regarding Archer Seven's racing manners in the home straight. Acting under the provisions of GAR 124, Archer Seven was charged with failing to pursue the lure with due commitment. Mr Sands pleaded guilty to the charge. Archer Seven was suspended for 28 days (1st offence) at Warragul and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>

After hearing submissions from Ms. Gough, viewing the available race footage and acting on their observations, Stewards deemed the performance of Pickles unsatisfactory. Pickles must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post-race urine sample was taken from Paw Yale - the winner of the event.</p>
