A 10 day stand down period was imposed.</p> <p>Stewards spoke to trainer Mr D Reardon regarding Thanks Jame's racing manners approaching and in the home straight. Acting under the provisions of GAR 125, Thanks James was charged with failing to pursue the lure with due commitment (by reason of injury). Mr D Reardon pleaded guilty to the charge. Thanks James must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>It was noted that the muzzle of Thanks James became partially dislodged during the running of the event.</p>
