Little Venice (lost ground in the home straight) underwent a post–race veterinary examination and was found to have a right hind ruptured toe ligament. A 14 day stand down period was imposed.

Stewards spoke to Ms Christine Haigh regarding the difficulty in boxing Redshift Victory in this event. A warning was issued pursuant to GAR 106(2) and Stewards will continue to monitor the box manners of Redshift Victory at future starts.
