Stewards advised Mr Davis that evidence of the breakdown will need to be submitted, to the satisfaction of Stewards, within 72 hours of the occurrence that caused the non-arrival. The matter will be re-evaluated upon receipt of this evidence.</p> <p>Supplementary Report – 5/12/24: The 28 day stand down was removed from Spinner Bait after Mr Davis provided Stewards with sufficient evidence of the vehicle breakdown.</p> <p>Classy Willow and Nana's Rebel were slow to begin. Acting under the provisions of GAR 125, Jilliby Millie was charged with failing to pursue the lure with due commitment (by reason of injury). Ms K.Collyer pleaded guilty to the charge. Jilliby Millie was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
