Race 1

SPORTSBET SAME RACE MULTI 6:09 pm 390m Tier 3 - Maiden Blinding Faith – Late scratching at 5:25pm due to weight variation (GAR 101). Blinding Faith is not permitted to compete for 10 days in any other Event. Trainer, Ms. Margery Quick was fined \$100.

Pursuant to GAR 75(6), track staff Mr. Shaun Boag did not act in any official capacity that may have in any way affected the outcome of this event.

A pre-race urine sample was taken from Crackerjack Lee.

Hey Ella was quick to begin. King Ron, Moraine Alfie and Morain Felix were slow to begin.

Moraine Alfie (racing manners turning out of the back straight) underwent a post–race veterinary examination – and was found to have a left back muscle injury, left track leg injury and bruising/contusion. A 14 day stand down period was imposed. Stewards spoke to trainer Mr. Glenn Judd regarding Moraine Alfie racing manners on the turn out of the back straight. Acting under the provisions of GAR 125, Moraine Alfie was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Judd pleaded not guilty to the charge. Moraine Alfie was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

Stewards spoke to Mr. Glenn Judd regarding his conduct during an inquiry. A reminder of responsibilities for detrimental comments was issued pursuant to GAR 165(a).

390m Tier 3 - Maiden	Two Bays (severely checked and fell turning out of the back straight) underwent a post–race veterinary examination and was found to have right shin soreness. A 5 day stand down period was imposed.
	Vista Why (checked and contacted running rail turning out of the back straight) underwent a post-race veterinary examination and was found to have a left tibia laceration. No stand down period was imposed.

Race 3 EUREKA CONCRETE 6:47 pm 450m Tier 3 - Maiden	A pre–race urine sample was taken from Lose My Number. Blazing Frankie, Reiko Terror and Blue Tick Tyrone were quick to begin. Moraine Spike and Lose My Number were quick to begin. A post race urine sample was taken from Reiko Terror - the winner of the event.

Lala Speed (contacted running rail truning out of the back straight) and underwent a post-race veterinary examination – no apparent injury was reported.

Race 6 TOWN & COUNTRY LINE MARKING 7:52 pm 450m Tier 3 - Grade 7	A pre-race urine sample was taken from Wardan Jilungin. Sabatini was slow to begin. The announcement of the All Clear was delayed for the Stewards to review the race footage after a bird (plover) was positioned on the track in the home straight and alighted as the greyhounds approached. After viewing the footage and acting on their own observations, the Stewards were comfortably satisfied that no greyhounds were materially affected so as to affect the outcome of the event. The All Clear was posted. Sabatini (checked soon after start and lost ground) underwent a post-race veterinary examination and was found to have both left and right shin soreness. A7 day stand down period was imposed.
Race 7 A1 SIGNAGE (1-3 WINS) 8:07 pm 450m Tier 3 - Restricted Win	A pre–race urine sample was taken from Speedy Khe Sanh. Hard Rotor, Go Now and Belle Extra were slow to begin. Speedy Khe Sanh raced wide turning into the home straight. Jolly Encounter and Hustle Nina raced wide in the home straight.
Race 8 SPORTSBET SET A DEPOSIT LIMIT 8:26 pm 450m Grade 5 T3	Sassy Swan – New declared weight of 25.8kg, last raced at 24.4kg. A pre–race urine sample was taken from Destini Rebel. Acoustic Flash was quick to begin.

Mr. Darren Petersen requested an early race endorsement for More Boost Rico. Stewards approved the request after an extensive examination prior to racing by the On–Track Veterinarian. More Boost Rico will compete in early races until further notice. More Boost Rico was slow to begin.

9:46 pm 390m	Lily Crackers (faltered turning off the back straight) underwent a post–race veterinary examination and was found to have left and right back muscle injury. A 60 day stand down period was imposed.
