A 10 day stand down period was imposed.</p> <p>Stewards spoke to Mr. Geoffrey Fisher regarding Blonde Mustang's racing manners in the home straight. Acting under the provisions of GAR 125, Blonde Mustang was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Fisher pleaded not guilty to the charge. In arriving at this decision, Stewards observed that Conroy Park had shifted in and collided with Jungle Fireball on multiple occasions in the home straight.
