Ms. Karen Pitt declined the option to have the greyhound re-examined. Stewards spoke to Ms. Pitt regarding Reposition's racing manners entering the back straight. Acting under the provisions of GAR 124, Reposition was charged with failing to pursue the lure with due commitment. Ms. Pitt pleaded guilty to the charge. Reposition was suspended for 28 days (1st offence) at Sandown and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Luna Mikado (faltered entering the home straight) underwent a post-race veterinary examination and was found to have a left back muscle injury. A 60 day stand down period was imposed.</p> <p>Following the running of this event, Stewards inspected the track around the home turn and deemed it suitable for racing.</p>

A 5 day stand down period was imposed. Stewards spoke to Ms. Danielle Smith regarding Sorry I'm Late's racing manners approaching the winning post). Acting under the provisions of GAR 124, Sorry I'm Late was charged with failing to pursue the lure with due commitment. Ms. Smith pleaded guilty to the charge. Sorry I'm Late was suspended for three months (3rd offence) at all tracks and must perform a Satisfactory Trials in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
