Race 1

4 RACES TODA 2:11 pm 390m Tier 3 - Maiden A urine sample was taken from Fill The Tank upon arrival at the course.

Paw Kinsley was quick to begin. Atomic Diva was slow to begin.

A post-race urine sample was taken from Spicy Seduction - the winner of the event.

Race 2

2:30 pm 390m Tier 3 - Grade 7 A urine sample was taken from Tinker Rays upon arrival at the course.

A pre-race urine sample was taken from Wardan Jilungin.

Wardan Jilungin and Majestic George were quick to begin. Groovin' was slow to begin.

Missy Highland and Groovin' raced wide turning into the home straight.

Tinker Rays (turned its head inwards in the home straight) underwent a post-race veterinary examination and was found to have a back muscle injury. A 7 day stand down period was imposed. Stewards spoke to Trainer Mr. Craig Burns regarding Tinker Rays racing manners turning into the home straight. Acting under the provisions of GAR 125, Tinker Rays was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Burns pleaded guilty to the charge. Tinker Rays must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

Crown Arya (turned its head outwards turning into the home straight) underwent a post-race veterinary examination and was revetted after race 7. Crown Arya was found to have a right gracillis muscle injury. A 14 day stand down period was imposed. Stewards spoke to trainer Ms. Tammy Kennedy-Harris regarding Crown Arya's racing manners turning into the home straight. Acting under the provisions of GAR 125, Crown Arya was charged with failing to pursue the lure with due commitment (by reason of injury). Ms. Tammy Kennedy-Harris pleaded not guilty to the charge. Crown Arya was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

A post-race urine sample was taken from Magic Tigeress - the winner of the event.

RSN GREY AREAS - WEDNESDAY & FRIDAY 4:57 pm 390m Tier 3 - Maiden Elphias Doge was slow to begin.

Tinker Gold (racing manners approaching the first turn) underwent a post–race veterinary examination – no apparent injury was reported. Stewards spoke to Mr. Craig Burns regarding Tinker Gold's racing manners approaching the first turn. Acting under the provisions of GAR 124, Tinker Gold was charged with failing to pursue the lure with due commitment. Mr Burns pleaded not guilty to the charge. Tinker Gold was found guilty and suspended for 28 days (1st offence) at Ballarat only and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

A post-race urine sample was taken from Elphias Doge - the winner of the event.

A1 SIGNAGE (1-2 WINS) 5:15 pm 390m Tier 3 - Restricted Win Kathlen's Entity, Make Us Dream and Moraine Demon were quick to begin. Pegasus Bale and Decoded were slow to begin.
