Mr. Inguanti declined the option to have the greyhound re-vetted. Stewards spoke to Mr. Peter Inguanti regarding Blue Benz racing manners approaching the winning post. Acting under the provisions of GAR 124, Blue Benz was charged with failing to pursue the lure with due commitment. Mr. Iguanti pleaded guilty to the charge. Blue Benz was suspended for 28 days (1st offence) at Warrnambool and must perform a Satisfactory Trial/s in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post-race urine sample was taken from Blue Benz - winner of the event.</p>

Crypto Tiger was slow to begin.</p> <p>Crypto Princess (tired in the home straight) underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to Mr. Robert Colpoys regarding the racing manners of Crypto Princess in the home straight. Mr Colpoys explained that Crypto Princess' performance may have been hindered by an unavailability to trial and build up fitness, but is optimistic of a stronger run next start. After considering Mr. Colpoys submissions, viewing the available race footage and having their own observations, Stewards took no further action.</p>
