Stewards spoke to Mr. Dennis Langley regarding On Song Bobby's racing manners. Acting under the provisions of GAR 124, On Song Bobby was charged with failing to pursue the lure with due commitment. Mr. Langley pleaded guilty to the charge. On Song Bobby was found guilty and suspended for 28 days (2nd offence) at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
