#### MEETING COMMENTS:

Satisfactory Trial – Returning from retirement - Spanky's Legacy trialled over the 311m from box 1, weight 28.5kgs, the greyhound was placed 2nd in a field of 4. The time of the trial was 18.15, the greyhound was beaten by a margin of 2 lengths. Spanky's Legacy was cleared.

Satisfactory Trial Results - Dennis Gallon trialled over the 311m from box 4, weight 35.8kgs, the greyhound was placed 1st in a field of 4. The time of the trial was 18.15, the greyhound won by a margin of 2 lengths. Dennis Gallon was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to K Houlahan, the trainer of Cool Milo regarding the length of time since the greyhound last raced. Cool Milo last raced on 5 November 2015. K Houlahan stated that the greyhound was returning from a right stopper injury. Pursuant to GAR 77A, Cool Milo trialled over the 311m from box 8, weight 32.2kgs, the greyhound was placed 3rd in a field of 4. The time of the trial was 18.15, the greyhound was beaten by a margin of 5 1/2 lengths. Cool Milo was cleared.
