Meeting Comments

Satisfactory Trial Results.

Stewards spoke to Ms. D. Carr, the trainer of Reality Girl regarding the length of time since the greyhound last raced. Reality Girl last raced on 16th July 2015. Ms. Carr stated that the greyhound was returning to racing after being on season, an injury to its left fibula and a change of trainer. Pursuant to GAR 77A, Reality Girl trialled over the 390 metre distance from box 3, weight 30.8kgs. The greyhound was placed 3rd, in a field of 4. The time of the trial was 22.43. The greyhound was beaten by a margin of 6.75 lengths. Reality Girl was cleared.

Stewards spoke to Mr. I. Chircop, the trainer of Jack MountyI regarding the length of time since the greyhound last raced. Jack Mounty last raced on 30th November 2015. Mr. Chircop stated that the greyhound was returning to racing after an injury to its left shoulder and a change of trainer. Pursuant to GAR 77A, Jack Mounty trialled over the 390 metre distance from box 8, weight 33.4kgs. The greyhound was placed 2nd, in a field of 4. The time of the trial was 22.43. The greyhound was beaten by a margin of 5.5 lengths. Jack Mounty was cleared.
