Race 1

Thor's Crest and Highfield Flirt collided several times aproaching the home turn, checking Thor's Crest. Swift Danny raced wide on the home turn.

A sample was taken from Paula Mechelle - the winner of the event.

We Gotta Prowler was vetted following the event. It was reported that the greyhound sustained spike wounds to the right hind metatarsal area, no stand down period was imposed.

Proven Mona was vetted following the event. It was reported that the greyhound sustained split webbing to the middle two toes on the right hind foot, a 10 day stand down period was imposed.

Eight Bells Toll was vetted following the event. It was reported that the greyhound sustained soreness to the right hind shin, a 14 day stand down period was imposed.

Grand Tornado was vetted following the event. It was reported that the greyhound sustained an injury to the right shoulder joint, a 5 day stand down period was imposed.

Stewards spoke to Mr. J. Donaldson, the trainer of the greyhound Grand Tornado regarding the greyhounds racing manners approaching the home turn. Acting under GAR 69(1) stewards charged Grand Tornado with marring. Mr. Donaldson pleaded guilty to the charge, Grand Tornado was found guilty and suspended for 28 days at Shepparton and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.

Kraken Tobias and Tat Duke collided on the first turn, checking Tat Duke. Kraken Tobias and Bullboar collided on the first turn, checking Bullboar. Kraken Tobias and Waimea collided approaching the home turn, checking Waimea and Midfield Maestro. Midfield Maestro and Fiery Melody raced wide in the home straight. Waimea was vetted following the event. It was reported that the greyhound sustained a lumbo-sacral injury, a five day stand down period was imposed.

Meeting Comments:

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr K Eyles, the trainer of Kraken Flash regarding the length of time since the greyhound last raced. Kraken Flash last raced on 15th March, 2016. Mr. Eyles stated that the greyhound is returning to racing after a hock injury that required surgery. Pursuant to GAR 77A, Kraken Flash trialled over the 390m from box 1, weight 29.4kg, the greyhound was placed 4th in a field of four. The time of the trial was 22.49, the greyhound was beaten by a margin of 8 lengths. Kraken Flash was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. B Mills, the trainer of Paw Sa Prize regarding the length of time since the greyhound last raced. Paw Sa Prize last raced on 7th October, 2015. Mr. Mills stated that the greyhound is returning to racing after whelping a litter of pups. Pursuant to GAR 77A, Paw Sa Prize trialled over the 390m from box 2, weight 28.7kg, the greyhound was placed 1st in a field of four. The time of the trial was 22.49, the greyhound won by a margin of 3.25 lengths. Paw Sa Prize was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. A Marum, the trainer of Sisco Pure regarding the length of time since the greyhound last raced. Sisco Pure last raced on 11th January, 2015. Mr. Marum stated that the greyhound is returning to racing after a suspension. Pursuant to GAR 77A, Sisco Pure trialled over the 390m from box 8, weight 29.5kg, the greyhound was placed 3rd in a field of four. The time of the trial was 22.49, the greyhound beaten by a margin of 5 lengths. Sisco Pure was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms J Walker, the trainer of Secretary Bird regarding the length of time since the greyhound last raced. Secretary Bird last raced on 5th December, 2015. Ms Walker stated that the greyhound was returning to racing after a suspension and a subsequent litter of pups. Pursuant to GAR 77A, Secretary Bird trialled over the 450m from box 1, weight 25.9kg, the greyhound was placed 2nd in a field of four. The time of the trial was 26.27, the greyhound was beaten by a margin of 0.75 lengths. Secretary Bird was cleared.
