Night Explosion last raced on 8th September, 2015. Mr Sneyders stated that the greyhound was returning to racing after a right achilles injury. Pursuant to GAR 77A, Night Explosion trialled over the 400m from box 8, weight 25.8kg, the greyhound was placed 4th in a field of four starters. The time of the trial was 23.15, the greyhound was beaten by a margin of 3.50 lengths. Night Explosion was cleared.
