Satisfactory Trial Results – Sun Of Irod trialled over the 400m from box 8, weight 31.8kg, the greyhound was placed 2nd in a field of four starters. The time of the trial was 22.98, the greyhound was beaten by a margin of 1.75 lengths. Sun Of Irod was cleared.

Satisfactory Trial Results – Cosmea trialled over the 460m from box 3, weight 28.6kg, the greyhound was placed 2nd in a field of four starters. The time of the trial was 25.92, the greyhound was beaten by a margin of 1.75 lengths. Cosmea was cleared.

Satisfactory Trial Results – Lily Bell trialled over the 460m from box 8, weight 29.6kg, the greyhound was placed 4th in a field of four starters. The time of the trial was 25.92, the greyhound was beaten by a margin of 20.75 lengths. Lily Bell was not cleared.
