Stewards spoke to Mr. R. Glass, the trainer of the greyhound Jordy Paige regarding the greyhounds racing manners on the first turn. Jordy Paige was vetted following the event. It was reported that the greyhound sustained a torn left hind nail, a 5 stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Jordy Paige with failing to pursue the lure with due commitment (by reason of injury). Mr. Glass pleaded guilty to the charge, Jordy Paige was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.
