Satisfactory Trial Results

Dolly Dyer trialled over the 390 metre distance from box 3, weight 28.1kgs. The greyhound was placed 3rd, in a field of 5. The time of the trial was 22.30. The greyhound was beaten by a margin of 6.25 lengths. Dolly Dyer was cleared.

Stewards spoke to Mr. S. Hamilton, the trainer of Vermont regarding the length of time since the greyhound last raced. Vermont last raced on 18th July 2015. Mr. Hamilton stated that the greyhound was returning to racing after injuries to its hock and back muscle. Pursuant to GAR 77A, Vermont trialled over the 390 metre distance from box 5, weight 32.4kgs. The greyhound was placed 5th, in a field of 5. The time of the trial was 22.30. The greyhound was beaten by a margin of 8.5 lengths. Vermont was cleared.
