	Meeting Comments Satisfactory Trial Results Stewards spoke to Mr. S. Trotman, the trainer of Misty Sannette regarding the length of time since the greyhound last raced. Misty Sannette last raced on 28th December 2016. Mr. Trotman stated that the greyhound was returning to racing after being on season and a right hock injury. Pursuant to GAR 77A, Misty Sannette trialled over the 460 metre distance from box 1, weight 27.9kgs. The greyhound was placed 3rd in a field of 4. The time of the trial was 26.23. The greyhound was beaten by a margin of 2.75 lengths. Misty Sannette was cleared.
