Satisfactory Trial Results - Eaglehawk Beffa trialled over the 500mt from box 1, weight 34.5kg, the greyhound was placed 2nd in a field of 4. The time of the trial was 28.46, the greyhound was beaten by a margin of 0.75L. Eaglehawk Beffa was Cleared.

Satisfactory Trial Results - Jetmeg Gemstone trialled over the 425mt from box 1, weight 25.6kg, the greyhound was placed 1st in a field of 4. The time of the trial was 24.24, the greyhound won by a margin of 5.75L. Jetmeg Gemstone was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. C. Croft, the trainer of Southpaw Knocka regarding the length of time since the greyhound last raced. Southpaw Knocka last raced on 5/12/2015. Mr. Croft stated that the dog was new to his kennels. Pursuant to GAR 77A, Southpaw Knocka trialled over the 425m from box 3, weight 28.4kg, the greyhound was placed 4th in a field of 4. The time of the trial was 24.24, the greyhound was beaten by a margin of 5.75L. Southpaw Knocka was Cleared.
