Pursuant to GAR 77A, Sunlit Cobber trialled over the 390mts from box 1, weight 32.8kg, the greyhound was placed 2nd in a field of 4. The time of the trial was 22:60, the greyhound was beaten a margin of 1.75L. Sunlit Cobber was Cleared.
