Mr B Shillington pleaded guilty to the charge, Draper Bale was found guilty and suspended for 28 days at Shepparton and directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2) (a) before any future nomination will be accepted.
