V Millington pleaded guilty to the charge, Get Me was found guilty and suspended for 12 months (all tracks) and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(c), before any future nomination will be accepted.

MEETING COMMENTS:

Satisfactory Trial Results

Cogitate trialled over the 390m from box 1, weight 30.1kgs, the greyhound was placed 1st in a field of 4. The time of the trial was 22.10, the greyhound won by a margin of 4 lengths. Cogitate was cleared.

En Kay Gee trialled over the 390m from box 3, weight 31.4kgs, the greyhound was placed 2nd in a field of 4. The time of the trial was 22.10, the greyhound was beaten by a margin of 4 lengths. En Kay Gee was cleared.

Ready Jet Go trialled over the 450m from box 8, weight 33.5kgs, the greyhound was placed 2nd in a field of 4. The time of the trial was 25.96, the greyhound was beaten by a margin of .5 length. Ready Jet Go was cleared.
