It was reported that the greyhound sustained an injury to the right monkey muscle, a 5 day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Sugar Roselee with failing to pursue the lure with due commitment (by reason of injury). Mr. Forbes pleaded guilty to the charge, Sugar Roselee was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.</p>
