Satisfactory Trial Results -(GAR 77A) - Stewards spoke to Mr M Marshall, the trainer of Melodramatic regarding the length of time since the greyhound last raced. Melodramatic last raced on 24 October 2015. Mr Marshall stated that the greyhound was returning from a season. Melodramatic trialled over the 390M from box 8, weight 27.6kg, the greyhound was placed second in a field of four. The time of the trial was 22.24, the greyhound was beaten by a margin of 10.75 lengths. Melodramatic was cleared.
