Meeting comments:

Satisfactory Trial Results -

Cape Shiraz trialled over the 450m from box 1, weight 31.8kg, the greyhound was placed 4th in a field of 4. The time of the trial was 26.06, the greyhound was tailed off. Cape Shiraz was not cleared.

Shazza's Gift trialled over the 450m from box 5, weight 25.5kg, the greyhound was placed 3rd in a field of 4. The time of the trial was 26.06, the greyhound was beaten by a margin of 5.25 lengths. Shazza's Gift was cleared.

Barn's Delight trialled over the 450m from box 8, weight 31.0kg, the greyhound was placed 2nd in a field of 4. The time of the trial was 26.06, the greyhound was beaten by a margin of 2.75 lengths. Barn's Delight was cleared.

Stewards spoke to Mr F. Zeinert, the trainer of Jimmy Marlow regarding the length of time since the greyhound last raced. Jimmy Marlow last raced on 11 February 2016. Mr Zeinert stated that the greyhound had been spelling and was new to the kennel. Pursuant to GAR 77A, Jimmy Marlow trialled over the 390m from box 2, weight 31.1kg, the greyhound was placed 3rd in a field of 4. The time of the trial was 22.41, the greyhound was beaten by a margin of 3.75 lengths. Jimmy Marlow was cleared.
