Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. L. Scott, the handler of Skyfire regarding the length of time since the greyhound last raced. Skyfire last raced on 29 November 2015. Mr. Scott stated that the greyhound was returning from a spell. Pursuant to GAR 77A, Skyfire trialled over the 390m from box 8, weight 34.1kg, the greyhound was placed 2nd in a field of 4. The time of the trial was 22.38, the greyhound was beaten by a margin of 3.5L. Skyfire was Cleared.
