Stewards spoke to Mr P Handley, the trainer of Brooklyn Babe regarding the length of time the greyhound has had between races. Brooklyn Babe last raced on 4th May, 2015. Mr Handley stated that greyhound had been finding trouble in the last few starts and had been freshened with a good spell.

Mr Chircop pleaded not guilty to the charge, Bush Caviar was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Dig Deep Bert was vetted and after being re-vetted following event 9, it was reported that there was no apparent injury found.

Stewards spoke to Mr R.Gatt, the trainer of the greyhound Dig Deep Bert regarding the greyhounds racing manners at the 150m mark. Acting under GAR 69(A)(1) stewards charged Dig Deep Bert with failing to pursue the lure with due commitment. Meeting Comments:

Satisfactory Trial Results (Blinkers) - Gaelic Peter trialled over the 350m from box 3, weight 36.2kg, the greyhound was placed 1st in a field of four starters. The time of the trial was 19.24, the greyhound won by a margin of 7 lengths. Gaelic Peter was cleared to race in blinkers.
