Satisfactory Trial Results

525m - Weight Trial

Krank Panda trialled over the 525 metre distance from box 2, weight 33.0kgs. The greyhound was placed 4th in a field of 4. The time of the trial was 30.98. The greyhound was beaten by a margin of 6 lengths. Krank Panda was cleared.
