#### Race 1

MEGAMERCH RURAL & PET

12:25 pm 390m Tier 3 - Maiden Mr. M. Cahill, trainer of Mickevin declared a new weight of 32.9kgs for the greyhound in accordance with GAR 39(2). Mickevin last raced at 31.7kgs.

Five Mississippi, Candy Kid and Calvadoss were quick to begin. Mickevin and Don's Magic collided soon after the start. Candy Kid, Mickevin, Calvadoss, Don's Magic and Redfin Fozz collided approaching the first turn checking Don's Magic, Candy Kid, Calvadoss and Gundy's Gift. Candy Kid raced wide approaching the winning post.

Game Spirit and Nirranda Hannah collided on the first turn checking Game Spirit, Nirranda Hannah and Cheryl's Boy. Nirranda Hannah eased approaching the home turn and tailed off.. Cudgee's Myla checked off Matchstick Girl entering the home straight. Game Spirit raced wide in the home straight. Parvati Patil and Lonesome George collided in the home straight.

Stewards spoke to Mr. K. Lloyd, the representative of the greyhound Nirranda Hannah regarding the greyhound's racing manners approaching the home turn. Nirranda Hannah was vetted following the event. It was reported that the greyhound sustained injuries to its left monkey muscle, right bicep muscle and right sartorius muscle. A 14 day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Nirranda Hannah with failing to puruse the lure with due commitment (by reason of injury). Mr. Lloyd pleaded guilty to the charge. Nirranda Hannah was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

A sample was taken from Cudgee's Myla, the winner of the event.
