Stewards spoke to Ms. D. Carr, the trainer of Secret Number regarding the length of time since the greyhound last raced. Secret Number last raced on 1st April 2016. Ms. Carr stated that the greyhound was returning to race after a right wrist injury. Pursuant to GAR 77A, Secret Number trialled over the 450 metre distance from box 1, weight 36.8kgs. The greyhound was placed 3rd, in a field of 4. The time of the trial was 22.47. The greyhound was beaten by a margin of 2.75 lengths. Secret Number was cleared.

Stewards spoke to Ms S. Ferguson, the trainer of Zabimaru Bale regarding the length of time since the greyhound last raced. Zabimaru Bale last raced on 1st March 2016. Ms. Ferguson stated that the greyhound was returning to race after a toe injury. Pursuant to GAR 77A, Zabimaru Bale trialled over the 450 metre distance from box 3, weight 32.1kgs.
