The greyhound was placed 2nd in a field of 4. The time of the trial was 22.29. The greyhound was beaten by a margin of 3.5 lengths. Dan The Man was cleared to race in blinkers.</p> <p>Stewards spoke to Mr. D. Brennan, the trainer of Due Process regarding the length of time since the greyhound last raced. Due Process last raced on 8th April 2016. Mr. Brennan stated that the greyhound was returning to race after a torn achillies injury. Pursuant to GAR 77A, Due Process trialled over the 390 metre distance from box 8, weight 35.4kgs. The greyhound was placed 1st in a field of 4. The time of the trial was 22.29. The greyhound won by a margin of 3.5 lengths. Due Process was cleared.</p>
