Mitcharlie Mia was vetted following the event. It was reported that the greyhound sustained a left bicep, right back muscle and left hock spike wound, a 7 day stand down period was imposed.

Stewards spoke to Mrs A Dailly, the trainer of the greyhound Shima Bar, and Mr T Dailly regarding the greyhounds racing manners approaching the home turn. Acting under GAR 69(1) stewards charged Shima Bar with marring. Mrs Dailly pleaded not guilty to the charge, Shima Bar was found guilty and suspended for 28 days at Sandown and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.

Stewards issued a warning to Mr. T. Brett, the trainer of Split Image regarding the greyhound's racing manners approaching the home turn.

Note: Greyhound 'Shima Bar' - RADB Appeal conducted 15/11/16. Appeal allowed. Penalties imposed pursuant to GAR 69(1) and GAR 69 (2) (a) lifted.
