Violets For Suzy last raced on 17th April, 2016. Mr. Matthews stated that the greyhound was returning to his kennels following a stint interstate. Pursuant to GAR 77A, Violets For Suzy trialed over the 390m from box 8, weight 26.0kg, the greyhound was placed 4th in a field of 5. The time of the trial was 22.65, the greyhound was beaten by a margin of 8.25lengths. Violets For Suzy was Cleared.
