A pre race sample was taken from Make It Happen.

Vintage Bling was quick to begin. Scarlet Scarlet and Maggie's Alone were slow to begin. Share and Phoebe Allen collided approaching the first turn, checking Share, which contacted the running rail. Zipping Lexi and Santana collided on the first turn, checking Zipping Lexi, Santana and Maggie's Alone. Phoebe Allen raced wide approaching the second turn. Zipping Lexi checked off Scarlet Scarlet approaching the second turn. Zipping Lexi checked off Scarlet Scarlet approaching the second turn. Zipping Lexi and Santana collided entering the back straight, checking both greyhounds. Santana checked off Zipping Lexi approaching the third turn. Share marred Vintage Bling approaching the winning post.

Share was vetted following the event. It was reported that the greyhound sustained an abrasion to the left hock, a 7 day stand down period was imposed.

Stewards spoke to Mr. B. Dewan, the trainer of the greyhound Share regarding the greyhounds racing manners approaching the winning post. Acting under GAR 69(1) stewards charged Share with marring. Mr. Dewan pleaded not guilty to the charge, Share was found guilty and suspended for 28 days at Cranbourne and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
