### Race 1

Re-vetted greyhound:-

Dr. Frankie was presented for a re-vet at the conclusion of kennelling and was cleared to race. Acting under GAR 83 Stewards directed that a urine sample be taken from the greyhound.

Satisfactory trial results:-

Tree Climber Liv trialled over 315 metres from box 2, weight 30.1, the greyhound was placed 1st in a field of 4. The time of the trial was 18.13, the greyhound Won by a margin of 5.75 lengths. Tree Climber Liv was cleared

Gats Caviar trialled over 315 metres from box 1, weight 26.2, the greyhound was placed 2nd in a field of 4. The time of the trial was 18.13, the greyhound Was beaten by a margin of 5.75 lengths. Gats Caviar was cleared.

Satisfactory trial results (GAR 77A):-

Stewards spoke to Mr. D. Knocker the representative of Aston Gaudi regarding the length of time the greyhound last raced. Aston Gaudi last raced on 11/05/16. Mr. Knocker stated that the greyhound was returning to racing following a broken on the right front foot.
