M McGuire pleaded not guilty to the charge, Sparkling Kitty was found guilty and suspended the greyhound for 3 months (all tracks) and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(b), before any future nomination will be accepted.

**MEETING COMMENTS:**

Satisfactory Trial Results - Suspicious Sam trialled over the 390m from box 1, weight 30.2kgs, the greyhound was placed first in a field of 4. The time of the trial was 22.21, the greyhound won by a margin of 4 lengths. Suspicious Sam was cleared.
