Ms Katiforis pleaded guilty to the charge, Might And Magic was found guilty and suspended the greyhound for 3 months (all tracks) and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(b), before any future nomination will be accepted.</p>
