Stewards spoke to Ms. S. Hastie the trainer of Muzzle Jump regarding the length of time since the greyhound last raced. M last raced on 7th February 2016 and is returning to race after several failed nominations. Pursuant to GAR 77A, Muzzle Ju over the 400 metre distance from box 3, weight 27.9kgs (weight trial). The greyhound was placed 1st, in a field of 4. The tilt trial was 22.92. The greyhound won by a margin of 1.75 lengths. Muzzle Jump was cleared. Tinaka trialled over the 400 metre distance from box 4, weight 28.7kgs. The greyhound was placed 3rd, in a field of 4. The
