Stewards spoke to Ms. T. Kennedy-Harris the representative of the greyhound Shooter's Irish. Stewards deemed the performance of Shooter's Irish unsatisfactory in this event and acting in accordance with GAR 71 Stewards directed that Shooter's Irish must perform a satisfactory trial all tracks before any future nomination will be accepted.

Meeting comments:-

Satisfactory weight trial results:-

Bemmar Terry trialled over 315 metres from box 8, weight 33kg. The time of the trial was 18.40 secs. Bemmar Terry was cleared.

Satisfactory trial results:-

Hurricane Patch trialled over 315 metres from box 1, weight 27.9kg, the greyhound was placed fourth in a field of 5. The time of the trial was 18.53 secs, the greyhound was beaten by a margin of 11.75 lengths. Hurricane Patch was not cleared.

Hurricane Josie trialled over 315 metres from box 3, weight 25.5kg, the greyhound was placed fifth in a field of 5. The time of the trial was 18.53 secs, the greyhound was beaten by a margin of 15.5 lengths. Hurricane Josie was not cleared.

In Like Flint trialled over 315 metres from box 6, weight 28.2kg, the greyhound was placed third in a field of 5. The time of the trial was 18.33 secs, the greyhound was beaten by a margin of 1.25 lengths. In Like Flint was not cleared, incident on the home turn.

Ends Well trialled over 395 metres from box 3, weight 30.5kg, the greyhound was placed third in a field of 4. The time of the trial was 22.72 secs, the greyhound was beaten by a margin of 5.25 lengths. Ends Well was cleared.

Galloping Leo trialled over 395 metres from box 1, weight 31.9kg, the greyhound was placed first in a field of 4. The time of the trial was 22.72 secs, the greyhound won by a margin of 3.5 lengths. Galloping Leo was cleared.

Cracking Joe trialled over 315 metres from box 1, weight 30.6kg, the greyhound was placed first in a field of 5. The time of the trial was 18.33 secs, the greyhound won by a margin of 1 length. Cracking Joe was cleared.

Crystal Shadow trialled over 525 metres from box 1, weight 31.0kg, the greyhound was placed third in a field of 4. The time of the trial was 31.00 secs, the greyhound was beaten by a margin of 8.25 lengths. Crystal Shadow was cleared. Greyhound was severely checked on the second turn.

Satisfactory trial result (blinkers on):-

Kyla's Cruiser trialled over 315 metres from box 5, weight 27.0kg, the greyhound was placed second in a field of 5. The time of the trial was 18.53 secs, the greyhound was beaten by a margin of 1.5 lengths. Kyla's Cruiser was cleared to race in blinkers.

Satisfactory trial result (blinkers off):-

Ultimate Connor trialled over 315 metres from box 8, weight 32.6kg, the greyhound was placed fourth in a field of 5. The time of the trial was 18.33 secs, the greyhound was beaten by a margin of 3 lengths. Ultimate Connor was not cleared to race without blinkers, incident on the home turn.

Satisfactory trial result (GAR 77A):-

Stewards spoke to Mr. D. Agius the trainer of Hurunui Jack regarding the length of time since the greyhound last raced. Hurunui Jack last raced on 12/06/16. Mr. Agius stated that the greyhound was returning to racing following a change of kennel. Pursuant to GAR 77A Hurunui Jack trialled over 315 metres from box 3, weight 36.2kg, the greyhound was placed second in a field of 5. The time of the trial was 18.33 secs, the greyhound was beaten by a margin of 1 length. Hurunui Jack was cleared.
