A 10 day stand down period was imposed. Acting under GAR 69(B)(1), the Stewards charged Push The Trolley with failing to pursue the lure with due commitment (by reason of injury). Mr. Matthyssen pleaded guilty to the charge. Push The Trolley was found guilty and Stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.
