It was reported that the greyhound sustained an injury to its right hamstring. A 5 day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged By The Gallon with failing to pursue the lure with due commitment (by reason of injury). Mr. Dapiran pleaded guilty to the charge. By The Gallon was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Stewards noted that the semaphore board for this event displayed Race 4 before it was corrected to Race 3 by the Judges and the All Clear was given.
